

# Trump plan to be rich, hints at abolishing I-T

United States President Donald Trump has once again advocated doing away with income tax for Americans, saying that it is "time for the US to return to a system that made us richer and powerful". He added that the US should be enriching itself by "tariffing and taxing foreign nationals".

Speaking at the 2025 Republican Issues Conference at the Trump National Doral Miami on Monday, in Doral, Florida, Trump outlined his proposal. AFP reported that the three-day planning session was expected to lay out Trump's ambitious legislative agenda.

"America's gonna be very rich again and its gonna happen very quickly. It's time for the United States to return to the system that made us richer and more powerful than ever before," the President said. He asserted that the US had no income tax prior to 1913, and it was the tariff system that made America rich in the past and gave previous presidents the capital to do work for the country.

"You know the US in 1870-1913 — all tariffs and that was the richest period in the history of the US — relatively speaking. And they set up a blue ribbon committee, the great tariff commission of 1887 and this commission had one function: 'what to do with all the money that we took in?'" he claimed.

"It was so enormous that they had no idea what to do with all of the money that we had. And again, Teddy Roosevelt was a beneficiary ... and he did all of those national parks and all of the



other things... he was given a vast amount of money, and that was all made through tariffs. We had no income tax, the income tax came in 1913," he added.

**'Tax Foreign Nationals to Enrich Our Citizens'**  
"As I said in my speech last week, instead of taxing our citizens to enrich foreign nations we should be tariffing and taxing foreign nations to enrich our citizens. Does that make sense? Right?" he asked the clapping crowd.

So, will the US remove income tax and replace it with tariffs? Trump has repeatedly voiced support for the move — even during his campaign to become President last year.

Tariffs are typically charged as a percentage of the price a buyer pays a foreign seller. In the US, tariffs are collected by Customs and Border Protection agents at 328 ports of entry across the country, according to an AP report. It added that mainstream economists are generally sceptical of tariffs, considering them a mostly inefficient way for governments to raise money and promote prosperity.

# 'Israeli troops must withdraw'

Lebanese Hezbollah chief Naim Qassem said on Monday that the group did not accept any justifications to extend the period for Israeli troops' withdrawal from southern Lebanon. "What comes after the period given to Israel's withdrawal? Israel has to withdraw because the 60 days are over. We do not accept any justification to extend for one

moment or one day," he said in a recorded televised address. Israel said on Friday that its army's withdrawal would last beyond the 60-day period stipulated in the ceasefire agreement, that ended on January 26, with the Lebanese group, saying the terms of the deal had not been fully enforced by the Lebanese state. The US said on Sunday the agreement between Lebanon and Israel would now remain in effect until February 18, Qassem said the group was informed that Washington initially proposed to Lebanese of-

ficials to extend the deal to February 28, which Hezbollah rejected. Lebanese caretaker Prime Minister Najib Mikati said during a meeting with US Ambassador Lisa Johnson that the country accepted adhering to the ceasefire agreement with Israel until February 18. Mikati said that requires pressure to end the Israeli "aggression and repeated violations" and to secure Israel's complete withdrawal from the occupied territories in the south, in return, his office said in a statement on Monday.

# Microsoft in talks to buy TikTok: US Prez

WASHINGTON: US President Donald Trump has said Microsoft is in discussions to acquire TikTok and that he would like to

see a "bidding war" over the sale of the social media app. When asked by reporters whether the US tech giant was preparing a

bid, Trump replied: "I would say yes" - before adding that there was "great interest in TikTok" from several companies.

- The Rashtriya Indian Military College is a Category 'A' Training Establishment of the Ministry of Defence. The College was established in 1922 with the primary aim of providing quality all round education.
- The Applications are invited from Boys and Girls for admission to Class VIII in the Rashtriya Indian Military College (RIMC) Dehradun (UK) for Jan 2026 Term which will be conducted at Specified centres of respective states on 01 Jun 2025. (Sunday).
- Entry Age: - Candidates appearing for the above test should not be less than 11½ years in age and should not have attained the age of 13 years as on 01 Jan 2026, i.e., they should have been born, not earlier than 02 Jun 2013 and not later than 01 Jul 2014.

(b) Viva-Voce-The date will be intimated later and will be held for only those candidates who qualify in the written exam. Intelligence, personality and communication skills of the candidates will be tested in the viva-voce.  
(c) Medical Examination- All The candidates Qualified after viva-voce will undergo a medical examination at Selected Military Hospitals and only those candidates found medically fit will be considered for Selection and admission to the RIMC. The medical examination of the candidates, forms only a part of the selection process and does not imply the final selection.
